**You have accepted a nomination from SK**

Congratulations! You have accepted a nomination from SK under their Provincial Nominee Program. By accepting this nomination, you agree to abide by the requirements of this provincial program, including the intention to reside in SK

Because you have accepted a provincial/territorial nomination you have been allotted an additional 600 points in the Express Entry Comprehensive Ranking System and it is likely that you will be issued an invitation to apply for permanent residence.

**REMINDER: Make sure that your profile is up to date and accurate**

Your profile is used to rank you against other candidates in the Express Entry pool.

You must ensure that the information you provided in your Express Entry profile remains truthful and accurate at all times. If your personal circumstances change (e.g. you get a new language test; have a baby; or start a new career), you must update your profile.

**WARNING:** If we invite you to apply for permanent residence, you will need to show proof of the information you gave us in your Express Entry profile. Your application for permanent residence will be refused if the information in your Express Entry profile is not true or cannot be verified. Untrue claims may result in you being barred from Canada for five years.

If we find that you misrepresented yourself (gave us false information or left out important details), we will refuse your application. You could also:

- be barred from entering Canada for at least five years,
- have a permanent record of fraud with IRCC, or
- be charged with a crime.

A PT nomination does not guarantee you are eligible for permanent residence. Immigration, Refugees and Citizenship Canada (IRCC) will accept an application for permanent residence from you as a provincial nominee, if you get nominated, but the final decision rests with IRCC and is subject to other admission requirements set forth by IRCC.

REMINDER: Start preparing your application

When nominated under the Provincial Nominee Program through Express Entry, you must also meet the program requirements for at least one of the federal immigration programs (Federal Skilled Worker Program, Federal Skilled Trades Program, and/or Canadian Experience Class). Learn about these programs by visiting our website.

It is important that you understand what you will be asked, if you are invited to apply for permanent residence. Each program has different application requirements.

If we invite you to apply for permanent residence, you will have 60 days to electronically submit a complete application. Some required documents (e.g. police certificates) may be difficult to obtain. You are encouraged to obtain these documents immediately, so that you can submit your application to us within the 60 days.
