Additional documents will not be accepted once an application is submitted, unless it pertains to personal or family member information changes such as name and/or marital status change, new dependent, updated passport, and contact information. If your occupation requires licensure from a Saskatchewan regulator you are still required to submit the application within the time frame noted above. However, we will hold

processing of the application until the licensure is received.
